Eligible Properties

Existing residential, multifamily apartment communities; market rate, mixed income, affordable.

Qualified Borrower

For-profit or non-profit single asset, single purpose entity.

Repair Amount

Repair Amount is limited to less than two major systems or \$19,293 (adjusted annually for inflation) times the high cost factor for the location.

Non-recourse Guarantees

Non-recourse loan, except for standard carve-out.

Low Fixed Interest Rate

Fixed rate subject to market conditions at time of Rate Lock.

Term/Amortization

Up to 35 years. Fully amortizing for the loan term.

Assumable

Fully assumable, subject to HUD approval.

Prepayment

Negotiable; typically, a specified lock-out period then declining prepayment for 10 years.

Occupancy Requirement

85% or higher.

Third Party Reports

Appraisal, Phase I, CAN and other reports as needed. Market study may be required if property is located in a declining area.

Mortgage Insurance Premium

- 0.25% of loan annually for all multifamily properties

Cash Out

Allowable.

Secondary Financing

Allowable.
